#### FINANCIAL POLICIES

- 1. Important Note: you will not be considered eligible for <u>additional ITI Financial Aid</u> until you have <u>submitted this form by the end of September</u> to the Student Administrator (<u>a.kramer@iti.ac.at</u>) and the Director of Finance and Administration (<u>s.hoogewerf@iti.ac.at</u>).
- 2. The tuition fee for BA, MMF, STM and STL programs is €9000 per academic year. STD students pay for each class they attend. Please see our website for further details on fees, living costs, and external financial aid: <u>https://iti.ac.at/admissions/costs-and-financial-aid</u>.
- 3. The actual calculated costs of tuition per student is approximately €25000 per year. The cost for our students, however, is deliberately kept at a minimum to enable qualified individuals from all over the world to study at the ITI. Every accepted student, therefore, receives a standard scholarship of €16000 per year of study. To continue to be able to grant these scholarships to our students in the future, we encourage those individuals who possess the financial means to make additional contributions to help cover the actual tuition costs.
- 4. The <u>additional ITI Scholarships</u> must be applied for each year and are reviewed on the basis of academic performance and financial need. Therefore, no scholarship is automatically extended to the next academic year.
- 5. Community Service: since the ITI is enriched by a community life, all students, regardless of financial or academic standing, are expected to contribute 2 hours a week to assist with the maintenance of the living areas.
